About Disability Law Colorado

Established in 1976, Disability Law Colorado's mission is to protect and promote the rights of people with disabilities and older people throughout the state through direct legal representation, advocacy, education and legislative analysis. Disability Law Colorado embraces the values of empowerment, self-determination, independence and inclusion in providing services.

In 1977 Governor Lamm designated Disability Law Colorado as the state's Protection and Advocacy (P&A) System which has authority under federal law to investigate allegations of abuse and neglect of individuals with disabilities. Since 1976, the organization has provided direct legal representation to more than 25,000 people with disabilities and touched the lives of at least 300,000 more through technical assistance, educational programs, and publications.

Since 1988 Disability Law Colorado has been the home of the Colorado State Long-Term Care Ombudsman and Legal Assistance Developer Programs. In 1995 we opened an office in Grand Junction. At this 40th Anniversary event we celebrate the founders, our Board members and staff, and our friends and supporters who have helped us achieve this important milestone.
